Report

Title of the Workshop: One Day Workshop on “Intellectual Property and Copyright Law”

In the Govt. Jagannath Munnalal Choudhary Mahila Mahavidyalaya, Mandla, M.P., a one-day workshop was organized on 28.04.2018 by the Department of Political Science. The speaker on the programme was Dr. Anjali Pandya, Assistant Professor, Department of Home Science. In the workshop the coordinator of the workshop Dr. S.N. Khare, Coordinator, IQAC (Professor, Department of History) and the patron of the institution Dr. Kalpana Shastri were present.

In the beginning of the workshop Dr. Shastri made the participants aware about the importance of the Intellectual Property Rights and Copyright Laws. After that Dr. S.N. Khare talked about the rules and regulations for registering copyright.

Further Dr. Anjali Pandya explained the title of the workshop as follows:

Intellectual Property (IP) and Copyright Laws protect original creations and innovations, ensuring creators' rights and encouraging innovation. Here's an overview:



Intellectual Property (IP) Laws:

1. Patents: Protect inventions, processes, and designs for a specified period.
2. Trademarks: Safeguard brand identities, logos, and symbols.
3. Copyrights: Cover original literary, dramatic, musical, and artistic works.
4. Trade Secrets: Protect confidential business information.

Copyright Laws:

1. Originality: Protects original expressions, not ideas.
2. Fixation: Requires tangible expression (e.g., written, recorded).
3. Duration: Typically lasts for the creator's lifetime + a specified number of years (e.g., 70 years).
4. Rights: Grants exclusive rights to reproduce, distribute, display, and perform the work.

Key Principles:

1. Ownership: Creators own their IP unless assigned or licensed.
2. Territoriality: IP laws vary by country.
3. Fair Use: Allows limited use of copyrighted material without permission (e.g., criticism, education).
4. Infringement: Unauthorized use or exploitation of IP.

Digital Age Considerations:

1. Digital Rights Management (DRM): Technologies controlling access and use.
2. Open-Source Licensing: Allows modification and distribution of software.
3. Creative Commons Licensing: Offers flexible, non-commercial use options.

International Treaties and Organizations:

1. World Intellectual Property Organization (WIPO): Promotes global IP cooperation.
2. Berne Convention: Establishes international copyright standards.
3. TRIPS Agreement: Sets minimum IP standards for WTO member countries.


The speaker of the workshop added that:


The workshop ended after the best wishes to all the participants from Dr. Kalpana Shastri and Dr. S.N. Khare. The number of participants in the workshop was 53.


