Title of the Workshop: One Day Workshop on "Possibility of Local Industries"

5. **Skills Gap:** Local industries may face challenges in finding skilled workers, particularly in specialized fields.


Strategies to Support Local Industries:

5. **Partnerships and Collaborations:** Encouraging partnerships between local industries, organizations, and governments can foster growth and innovation.




