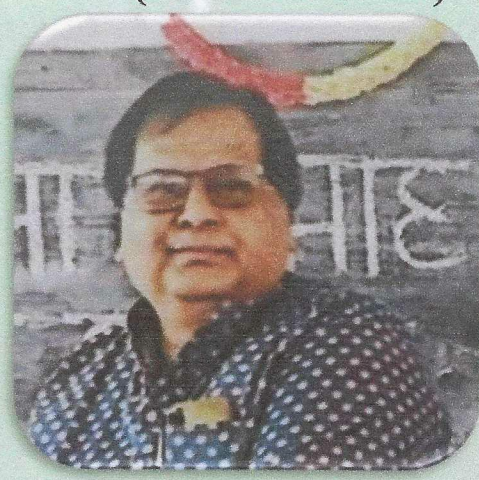


- IP rights are essential for businesses and individuals to protect their innovations and creations.

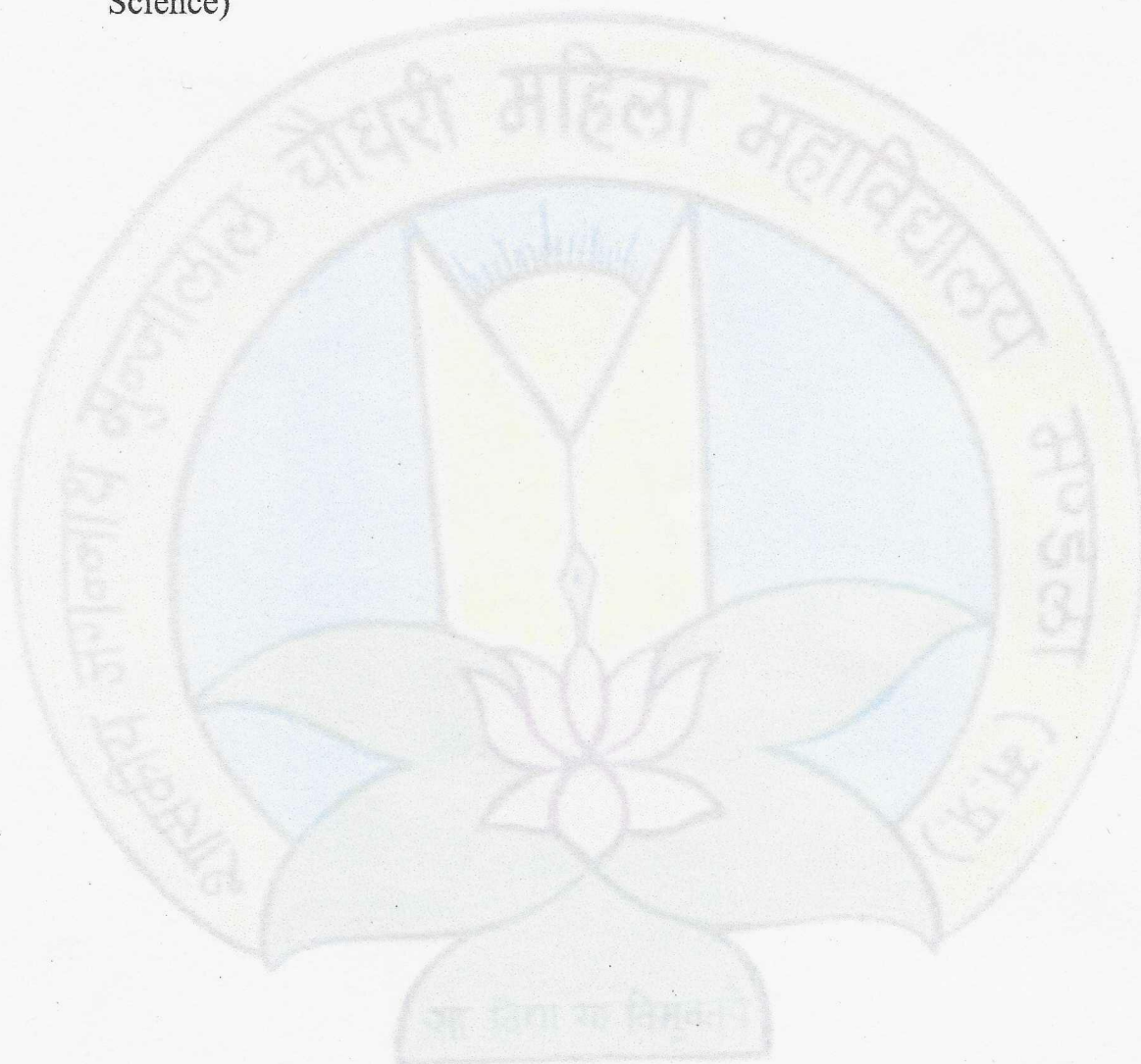


